**ORDER:**

Government in Circular Memo 1<sup>st</sup> read above, instructions were issued to the District Collectors in the State except Hyderabad to constitute multi-disciplinary teams consisting of Tahsildar, MPDO and Assistant Engineer (Housing) at Mandal level for verification of the applications received during Rachabanda programme and confirming the eligibility of the applicants as per the eligibility criteria and procedures mentioned in the Annexure I and II of the said circular.

2. In the reference 2<sup>nd</sup> read above, the Managing Director, A.P. State Housing Corporation Limited, among other things, reported that as per the instructions of Government the districts have entered the eligible applications and the details of 14,17,139 eligible beneficiaries, as on 23.09.2011 and it is expected that the District Collectors will complete the total verification of Rachabanda applications and data entry in another few days and the total figure may be around 15 lakhs. The Managing Director, A.P. State Housing Corporation Limited has stated that the Group of Ministers constituted for Rachabanda Programme, while reviewing the status in the month of August 2011, proposed to sanction the houses against the applications received under Rachabanda programme in phased manner. The Managing Director, A.P. State Housing Corporation Limited, has requested the Government to sanction 6,00,000 houses both for Rural and Urban areas (i.e.5,40,000 houses for Rural and 60,000 houses for Urban) with a unit cost of RPH house i.e., Rs.45,000/- and UPH i.e., Rs.55,000/- under Rachabanda Programme in the State for the year 2011-12 and furnished eligibility criteria and guidelines for sanction of houses.

3. Government, after careful consideration of the circumstances stated by the Managing Director, AP State Housing Corporation Limited, Hyderabad in his letter read above, hereby accord sanction for construction of 6,00,000 houses against the applications received during the Rachabanda-I of 2011-12 who are found eligible and registered on line, both for Rural and Urban areas (i.e.5,40,000 houses for Rural and 60,000 houses for Urban) with the unit cost of Rs.45,000/- for RPH house (i.e. Rs.13,200/- Govt. Subsidy, Rs.31,300/- Loan Component and Rs.500/- Beneficiary Contribution) for Rural areas and unit cost of Rs.55,000/- for UPH house ( i.e. Rs.6,000/- Govt. Subsidy, Rs.47,000/- Loan Component and Rs.2,000/- Beneficiary Contribution) for Urban areas under Rachabanda. Out of 6,00,000 houses, 3,37,680 houses (i.e. 3,24,000 houses for Rural and 13,680 houses for Urban) would be for SC / ST beneficiaries for whom, additional loan of Rs.20,000/- and Rs.30,000/- is sanctioned in Rural and Urban areas respectively, over and above the unit cost as is being sanctioned under INDIRAMMA in all Phases. The total project cost of Rs.344904.00 lakhs. The detailed financial pattern is as follows :

4. The Commissioner, Weaker Section Housing Programme is requested to approach the Government for release of amount from the Budget provision, as and when need arises depending on the pace of completion of houses.

5. The eligibility criteria and guidelines for sanction of the houses sanctioned in para (3) above, is appended as Annexure-I to this order. The district wise allocation of houses both for Rural and Urban and percentage of houses for SC / ST / Minorities and Others both Rural and Urban is as shown in the Annexure-II appended to this order.

6. The District Collectors / Executive Directors (H), APSHCL, shall sanction houses with the approval of the District Incharge Minister.

7. The Managing Director, AP State Housing Corporation Limited, District Collector/Executive Director, APSHCL shall take necessary further action in the matter accordingly.

8. This order, issues with the concurrence of Finance ( Expr. Housing) Department vide their U.O.No.9967/80/Exp.Hsng/2011, Dated: 3.10.2011.

**ANNEXURE - I**

**(G.O.Ms.No. 33 , Housing (RH.A1) Department, dt:18.10.2011)**

- (i) Beneficiary must be eligible as per INDIRAMMA guidelines.
- (ii) The applicant should have a valid White Ration Card and the ration card shall be in her / her spouse name/his name (in case of unmarried/ widower / physically handicapped).
- (iii) No one in the family should have been sanctioned a house earlier in the family of the person under any housing scheme.
- (iv) The house in which family is living presently shall be Semi-Permanent house or a hut.
- (v) The applicant shall possess sufficient site for construction of house or shall request for new house site patta / possession certificate.
- (vi) Only one pucca house per family shall be considered.
- (vii) The District Collector shall sanction the houses by issuing individual sanction proceedings with the approval of the District Incharge Minister.
- (viii) The Collectors should ensure the beneficiary proposed for sanction has been found eligible as per the eligibility and procedure mentioned in Government Circular Memo No:664/RH.A1/2011-1, dt:31.3.2011.
- (ix) The beneficiaries must be selected only from out of the list registered by the District Collectors in the online system after verification of the applications received during Rachabanda.
- (x) While issuing sanctions, the District Collectors shall ensure that the minimum number of prescribed houses of SC/STs, Minorities as mentioned in Annexure- II is strictly followed.
- (xi) While sanctioning the houses the District Collector may give priority for sanctioning houses in clusters and in such a manner to reach hut-free status in the gram panchayat/village.
- (xii) Wherever the beneficiaries fall under Category-II, the District Collector shall take necessary action through the Revenue Department for issue of pattas / possession certificate, wherever eligible duly following relevant Government orders, rules and guidelines.

- (xiii) Wherever the beneficiaries fall under Category-III, the District Collector shall take necessary action, in consultation with Social Welfare Department, for acquisition of land and making the land available to the Housing Department with suitable development, including land leveling etc. so that the site is suitable for construction of houses.
- (xiv) Whenever the Collectors are sanctioning the houses, the Collectors shall get it ensured through the PD(Housing), the District Supply Officer and the concerned Tahsildar that the beneficiary is eligible BPL beneficiary for the housing programme having a valid ration card and patta/possession certificate.
- (xv) Immediately, after sanctions, the Collectors would also ensure that the PD(Housing) take necessary action for completing the online registration in 39 column format in full shape along with details of individual bank account of the beneficiary.
- (xvi) When once the beneficiary details are confirmed, beneficiary name along with ID should be got generated so that further action for grounding of the houses can be taken up.
- (xvii) For grounding, measurement, check measurement, payment, the instructions and guidelines issued under INDIRAMMA housing programme as applicable on date shall be scrupulously followed.
